- Stephen talked about the successful OST silhouette installation day. It was years of struggle to put together the funding then 2 years to secure the permit on DOE land. The Project is finished and looks great!
- Stephen did an Interview for KZMU radio. The show later aired on September 6th, 2022 and can be found in the KZMU radio archives. We also discussed the plight of the Utah wild horses (BLM Mustangs) and policy to drastically reduce wild horses from public lands. We did a second radio show on KZMU Radio about the Sulphur HMA horses that Stephen and Naomi adopted. That show later aired on September 29th, 2022.
- Fall Endurance Ride volunteers: we discussed the Moab Canyons Endurance Ride and the need for volunteers. That event took place on September 30 to October 2nd.
- Trail Mix report by Stephen. Trail Mix is now referred to a GCAT (Grand County Active Trails). We discussed a cattle guard in Canopy gap that has no horse gate for riders. Some riders had to let down the fence to get around it. We made contact with SITLA they will try to correct the problem ASAP. Stephen reminded the USFS about the corral proposal at Medicine Lake.
- We mentioned a new book called "Tracing Time" by Greg Childs about petroglyphs in the Colorado plateau.
- Stephen gave a report from the BCHU state meetings. We discussed the fact that motorized users are using equestrian designated camp spaces on public lands. During the Labor Day

weekend, we should document any equestrian camps being used without horses present. The local BLM office put Day use only, horse trailer parking signs near our corrals at Courthouse Rock.

- We still have Canyonlands BCH hats available. (edit: Not anymore unless you haven't received yours yet)
- ANY Old Business? We have a group ride planned in Arch Canyon in the Bears Ears. Final date to be set first or second weekend of October. Melissa (Missy) will lead the ride.
