Before Mary and I left for our vacation, a friend contacted me and asked if I was aware that a private landowner was removing lots of trees in the Bunting Area and below Cottonwood Canyon. This friend told me that the operator got out of the tractor and told him they may be building housing units in the Bunting Area. The operator told my friend that this was private land.

Mary and I drove out to Cottonwood Trailhead. There appeared to be no impacts around this Trailhead. Lots of trees have been removed on an estimated 2 to 3 maybe 4 acres of level ground in the Bunting area. There are two canyons that come together where rain water may flow down to this flat area which has been cleared. The owner or maybe a surveyor have planted wooden stakes on the ground and strung tape to show a boundary.

On August 7, I returned to the site to take photos. There had been more work done with the larger tractor. I inspected the area and took 4 photos. We decided to go to Kanab City Offices to meet and talk with Jake Dutton who handles Roads and other Public Works. The Receptionist greeted us and told us Jake was out of the office today and the Receptionist told us that Janae Chatterley, who is Chief Building Officer (CBO) would be returning to her office soon.

The Receptionist used the electronic maps that were in the computer and we helped her see the computer's site we were calling Bunting Area. We explained where the owner's

tree clearing was on the map. If a heavy rain storm comes down the two canyons it could have real impacts on infrastructure, vehicles, etc.

Janae Chatterley returned to her office. She is the CBO (Director, Building Department/Land Use Department), and spent time with the Receptionist who relayed what she heard from us. Janae asked the Receptionist to tell us that she would be doing further research before a permit is approved. Mary and I thanked the Receptionist and left the Office.
