2. **Moore Cyn** – April 12 – 13, 2024. We are planning a campout at the Equestrian Campground and a work project on Moore Canyon. **We will have a group dinner on Friday, April 12.** We hope everyone will come and enjoy each other's company, even if you don't camp or ride.
3. **Possible Kids Day/Horsemanship clinic** – discussion of a future kids day. This will need to be discussed and planned. Possibly in the Fall or in 2025, we are open to ideas.
4. **Josephite Point** – this project can be done in one day and will be determined later.
