Chainsaw Training have completed three classes with another one planned for June 28 **Volunteer Hours**- each member can enter their own or forward to Wayne and he will enter them.

Rod – **National News**- Mike Lee is proposing to reintroduce the land sale portion of the budget bill, There is a petition that we can sign to oppose the sell off of pubic lands in the Senate Reconciliation Bill. Wayne agreed to sign the petition for SRBCH.

Bryce Canyon National Park has notified Rod they are working on a new management plan for public horse use in the park. He will get an early copy to review.

COMPLETED PROJECT:

Gentry Hollow Packing Project: Packed in 60 6"x6"x4" water bars and 120 steel stakes. It took seven people 3 days to complete. Having the water bars and stakes prepositioned allowed the State Trail crew to install 52 water bars. They estimated that without our help they would have only been able to install 20.

NEW PROJECTS:

Forest Service Trail Maintenance- Trails we have maintained in the past:

Mill Canyon, Flood Canyon, Candland Mt, Horse Canyon, Staker Trail, Old Folks Flat, Shoo Fly, Black Canyon, Josephite Trail, Cove Trail, 2nd Water, Little Bear, Big Bear, Fish Creek.

- We need to see how many trails we can/plan to clear this year.

Kacie Healy- New Forest Service Rec- wants to know what trails we clear as they are cleared. Hope to prevent duplication of effort.

State Trail Crew will be in Huntington Canyon July 14 & 17- we will be directing and guiding the work

Decided to concentrate our efforts in Horse Canyon. Will move to Flood Canyon if time.

Would have the crew widen the lower portion of the trail and remove rock barriers in Horse Canyon

Wedge Management Plan- out for scoping sometime in June for 15 days

Need to let everyone know when this is out for scoping comments. We need to comment on our approval of the equestrian trail head and that we want horse use prioritized for the trail head.

Chain Saw Certification -Arranged (tentatively) to provide training for some motorized volunteers on June 28
