BCH Ride at Navajo Lake

What a great day on the mountain with beautiful weather and 20 of our members and guests showing up for the ride. Some that have not ridden with us for awhile and a joy to see them again. Arriving for the ride today were: Ann Guhman, Chuck Schlicht, Chris Hall, Larry Bell, Maria Harris, Connie Jackson, Vic & Jan Middleton, Keith Christensen, Michelle Berthoty, DeAnn Fieselman, Jodi Blatter, Roshelle Bromley, Timandra Fawson, Lucy Bromley, Mikayla Johnson, Ellen & Elvin Hensley, Dana Millsap, and Paul Sloane. Everyone was impressed with the new paved road along the south side of the lake, except for a few horses that were not so impressed when asked to cross it.

As it sometimes happens when you have a lot of folks traveling a longer distance we don't all arrive as planned so we got off to a staggered start but eventually we all met along the trail. This actually worked out guite well as we were not all in a large group at one time.

As we had done before, we chose to ride the north side of the lake to the east end crossing the Lava field and stopping for lunch before crossing the road onto the trail heading back west on the south side of the lake. About mid-lake the trail forks to the south and up the hill you go reaching an elevation of around 9,000 ft. From there you ride the ridge line until you connect with the Virgin River Rim trail which takes you down the mountain to the west end of the lake where we crossed the road again and on to where our rigs were parked.

Some riders chose not to continue past the lunch spot as they did not want to tackle the mountain trails and longer ride. After lunch the faster horses went ahead and did their thing at their speed. We came across a few mountain bikers who were all considerate of the horses. Came across some deer too, one just stood to watch the horses pass by just a few yards away. As it seems to always happen the storm clouds rolled in around 4PM or so and we began getting a few sprinkles during the latter part of the ride but no real rain.

The Forrest Service or somebody was taking serious the thinning out of the trees and undergrowth. There was an impressive amount Teepee shaped stacks of wood everywhere for a long distance along the trail. A welcome sight for fire and beetle control.

In all we were five and a half hours from start to end including lunch and other small delays. As I said at the beginning of this story 'What a great day to be on the mountain'.

August 8, 2017

The **BCHUSW** Chapter meeting was called to order August 8, 2017 at the St. George Community Center by President Paul Sloane. In attendance were: Paul Sloane, Vic Middleton, Freddy Dunn, Dennis Peters, Susan Hanson, Keith Christensen, Judith Mayfield, and Jeanette Blasdell

Minutes: Minutes were accepted as published in the newsletter.

Treasurer' Report: Judith Mayfield presented the January through July Profit & Loss Previous Year Comparisons. Our total income is \$3,526.11 as compared to last year's total of \$4,333.95. Our net income at this time is \$275.50 as compared to last year's -\$148.61. Our total assets as of July 1 is 6,334.95. A motion was made, seconded, and passed to approve the presented report.

Report from National: Freddy Dunn reported current happenings at the national level and reminded members to call their congressmen. Two important areas currently getting a lot of attention are Bikes in the Wilderness that BCH does not support and No Red Tape that outdoor groups along with BCH are in support of. Freddy expressed the importance of contributing to the \$5 A Month Club as it is one way BCH can document how much our members believe in our cause. At the national level BCH was awarded a \$5,000 grant from an Austin group.

Old Business: The June 10th White Rocks ride was canceled due to fire in the area.

New Business:

- A motion was made and passed to reimburse Paul \$27.71 for Pine Valley corral repair materials, and also to reimburse Judith \$30.76 for envelopes and stamps.
- A request was made for participants in a four leg race to benefit 47 Day's Dixie. The race will have one leg constituting a horse race, followed by two legs of bike racing, ending with a short leg of running. The horse and bike race legs will be four miles each and the run will be about ½ mile. Each leg will be separat competitors. Look for more specific details in the newsletter.
- Visitors requested members to hook up with in Pine Valley 8/13-8/15. Freddy sent out a separate email to provide assistance.
