

Search for Britton Kelsey

Friday evening residents of Dammeron Valley received an automated message from the Washington County Sheriffs' office about a 15-year old boy missing at Red Mountain. Soon after that I received a call from a Dammeron Valley Fire Department volunteer, asking about getting search assistance on horseback. Arrangements were made and Freddy Dunn sent an email blast to our members asking those able to help to meet between 7 and 7:30 AM Saturday morning at Red Mountain trailhead.

It was 22 degrees F as I left Dammeron with my mare, but temps rose as the sun revealed itself. New member of our chapter Kathy McGann, Deja and Sierra Schweitzer and Steve Julian arrived and we five were dispatched to the southern trails to search for the missing hiker. It was now pushing 18 hours missing. Our routes were quite aways from where the family had hiked and son went missing and had not been searched by the numerous volunteer hikers and county search and rescue teams. Horses covered the areas within 4 hours and helped eliminate those sections as possible locations.

Additional riders came after we started; Aaron, Matt and Jason McArthur plus Ty and Drew Wilcox. I did not get to meet them and don't know what assistance they provided. Thank you for coming out. It was an amazing turn out of volunteer help that hiked and searched where Britton had last been seen. A lot of Search and Rescue members were out on ATV's and UTV's. As we finished at about noon, Search and Rescue had a lead with footsteps they were pursuing, helicopter included. By about 4:30 PM Britton had been found in good shape and returned to his family. In the end, that's what matters. The young man will have quite a story to tell over his lifetime. His family expressed their appreciation for having horses help that day. I'm glad we were able to have a very minor role in that story. Happy trails...

Public Lands & Recreation Update

S. 1695 – "Bikes in Wilderness" Bill

Coordinated a response by BCHA and allies prior to a Senate Natural Resources (ENR) Committee hearing that included S. 1695, the "Human-Powered Travel in Wilderness Areas Act." Authored and submitted BCHA testimony in opposition to the bill; co-authored and submitted testimony in opposition of the bill by a coalition of regional and national trail organizations affiliated with the Partnership for the National Trails System (PNTS). Worked with BCH Alaska on their submittal of testimony opposing S. 1695 to ENR Chairman Lisa Murkowski.

Great American Outdoors Act – Implementation

Conducted a webinar for BCHA member on how to influence GAOA spending by the US Forest Service at the local level in order to facilitate the deferred maintenance of trails, etc., important to horsemen in Fiscal Years 2022 through 2025.

Non-Equestrian use of Horse Camps

Brought the issue of people without stock occupying equestrian campsites on national forest lands before American Horse Council's (AHC's) Recreation, Trails and Land Use Committee. The committee voted unanimously to recommend to AHC's Board of Directors that AHC lend assistance in BCHA's search for solutions to resolving the issue.

Electric Bikes and the Lincoln NF

Crafted "pre-decisional objections" that were submitted by BCH New Mexico in response to a Draft Decision Notice for a trails plan in the Lincoln National Forest. Despite our victory in moving the Lincoln NF to reverse its proposal to allow e-Bike use among the non-motorized trail system, the filing of objections will guarantee BCH New Mexico a "seat at the table" in the forthcoming objections resolution process. Should other parties attempt to negotiate the e-Bike ban, BCH New Mexico will have an opportunity to voice support for the decision by the Forest Service.

Pacific Crest National Scenic Trail – Foundation Document

Represented BCHA as part of an inter-organizational and inter-disciplinary team during six 3-hour virtual workshops to craft a "Foundation Document" for the PCT. The Document will serve as the underlying guidance for administration and planning decisions related to the PCT. It will describe the core mission of the trail by identifying the trail's purpose, significance, fundamental and other important resources and values, and interpretive themes. The primary advantage for an agency—in this case, the US Forest Service—to develop a foundation document is that it provides a framework for the agencies (USFS, NPS, BLM, etc.) to integrate and coordinate all types and levels of planning and decision making from a single, shared understanding of what is most important about the trail.
