Backcountry Horsemen of Utah Southwest Chapter 2021 Year End Report

The Southwest Chapter continued its reputation as a "chapter of accomplishment". We have a diverse geographical landscape ranging from 1,200 ft elevation to 9,000 ft in which to ride and maintain the trails and enjoy year around riding.

Activities:

- This Chapter was founded on July 1, 1995, celebrating our 26th year
- We had a membership increase from 74 last year to 90 this year
- We had 10 scheduled chapter meetings and 10 scheduled chapter rides
- We accumulated 131 work hours, worked on 88 miles of trails, spent 53 hours traveling some 1,559 miles to do our work.

Other activities and projects were:

- Educational presentation on Satalite Communication devices for safety
- Published arrticle in Newsletter regarding dogs on the trail
- Produced (business card size) Trail Etiquet Cards to pass out while riding
- National Public Lands Day Did a trailhead tumbleweed cleanup project
- Hosted two men from WY, who in turn donated \$100 to be used to increase membership
- Installed 18 signs at Cottonwood Trailhead asking people to cleanup manure
- Replaced original signs on bridges in Pine Valley
- Organized and conducted a special Play Day event to stimulate membership. Installed 20 obstacles, 35 riders participated in the event netting four new members, one of which joined as a Benefactor member for \$500.
- Working with the USFS on new steel corrals in the Pine Valley Equestrian Campground
- Held our annual Dutch Oven Dinner and Auction Event and Annual election of Officers.
