Back Country Horsemen of Utah – Southwest Chapter. VALLEY of FIRE Group Ride 01/13/2024 By Aspen Rider

Our BCHA group welcomed the 2024 trail riding season in with an epic ride in Vally of Fire State Park, Nevada. It was clear blue skies as our group met around 10am near the East entrance, parking at the Lake Mead National Recreation Area welcome sign. Our group was 11 members strong. Our youngest rider today is Bryson Zetterquist on the handsome Buckskin Billy. Bryson's dad, Bryan "Z" Zetterquist, is riding the American mustang Willow. Lin Hokana, our chapter's President, is riding his chill gelding "Mr. T." Aspen Rider is on her little sorrel mare Penny. Julie Dunn (our newest member) joins us on her mare "Buttons" for their second voyage with our group. John West brought his foxy Fox Trotters Magie and Lacy so Monty Hawks could join in on the fun. Our Panguitch rancher members, the Hatch family, said they needed to come "defrost." Ron Hatch is riding his gray Quarter Horse. Tom Hatch is mounted on his beautiful Buckskin, and representing our groups' sole mule of the day: Travis Hatch is riding a unique colored/reddish mule. This pair will be in their element stepping down these rocks and today's many sand-stone sections. Enter the smooth moving group: we are joined by John West and his friend Monty Hall on their Missouri Fox trotters. We are thankful for our trail leader Deja Schweitzer on the smooth, all terrain mare: "KissMe."

Valley of Fire consists of bright red Aztec sandstone nestled in gray and tan limestone mountains. The plant community is dominated by widely spaced creosote bush, burro bush, and brittlebush. Our riders and horses are conscientious to avoid the beaver tail and cholla cactus, which are also common. After getting past the vast amount of interesting sandstone, our first notable landmark is "Elephant Rock." There are several elephant shaped sandstone edifices, but the horses appreciate this one the most as it is a chance to stop and breathe after a sandy ascent. Next up is the chance to ride your animal through "El Portal Arch!" A wild west experience to be able to ride your horse through an arch of carved sandstone!

Today's ride consists of several technical sandstone sections along with a trudge through the sand wash. There is so much to see that it is practically a game of who can spy the next arch or interesting formation. Static rocks are not the only thing to spy among the sandstone. Scaling the red rocks are the iconic big horn sheep.

Those who have ridden this ride anticipate what is considered the "highlight" which is our lunch spot in "God's Bowl" or "Silica Dome." Those who have never seen this spot don't know that the best is yet to come. Our decent into this bowl gives the rider the view of massive amounts of white sandstone starkly separated by layers of red stone. It is an epic view as the animals rest and our members mingle for lunch.

In total our group rode 10.7 miles in 4 hours with 1,105 feet of elevation gain. Wild West desert views don't get much better than this! Lucky and few are we who get to experience this ride from the backs of horses. We thank our leader, Deja. She had the task to lead our group when the original leader had an unexpected issue at home that precluded him attending this ride. Deja led our group safely and directly through this rugged trail which is often difficult to visualize. We got some amazing photos and some epic memories from our January BCH Group Ride!

December 2, 2023 Minutes

This was a brief meeting combined with the annual fund raiser.

The election of officers took place. After taking nominations from the floor, the current board members were elected to remain on more year. A motion made and carried to accept December minutes.

Treasurer's Report: Jeanette Blasdell

November Budget Update: A lot of people have been registering on line which is a positive. Overall membership revenue has increased.

December Budget Update: The net profit from fund raiser was less than half of last year; fewer attending, fewer auction items and catered meal expense. 2023 attendance was 100, 2022 was 114. The expense for meals was greater than the revenue from renewed memberships; net profit comes from the auction. A motion made and approved to accept the November and December treasurer's reports.

Old Business:

New officer business cards – Lin – Officers are to remain the same

BCHA Comments BLM re. Red Cliffs Desert Reserve - Lin

Lin provided his input but it was not on behalf of the chapter. Rod Player with BAHA also submitted comments.

New Business:

Review of Draft Annual Budget for 2024 – Jeanette Blasdell presented a tentative draft budget with proposed categories. Keith Wheeler made the recommendation that the budget for the Zion grant be kept separate and expenditures against those funds come out of the grant budget (remove from the chapter regular budget). Other recommendations to expense category amounts were made. The recommended revisions were made and the proposed budget as presented is balanced. A motion was made to accept the proposed annual budget and it was approved.

2023 President's Annual Report to BCHU – Lin circulated a year-end report of all activities reported to BCHU. A copy was circulated via email to all members and at the meeting for members to review.

Chapter Venmo Account – Deja indicated that a letter needs to be to finalize this process; Lin will send it to Jeanette and Deja to send to Venmo.

Reminder: 501c3 annual IRS report is due by May 15 each year; treasurer or secretary to sign off

Annual Dues Increase @ January 2025 – Lin: FYI BCHA will increase membership dues by \$5 for 2025. Whether the chapter will absorb the increase or bump the dues will be determined later this year.

Confluence Park fencing – Lin will find out the status of the livestock that had prevented use of the trails going northwest from the trailhead. Livestock is gone and the fencing to contain them is still incomplete.

Annual Fund Raising/Membership Drive Dinner: Lin, Deja, Debbie, Jeanette

Candy and Plaques Status – the candy and plaques have all been delivered to sponsors, as well as thank you letters.

Membership – We currently do not have a membership chair person. This position is open, an email to be sent out, asking if there's anybody interested and define the duties.


A ride committee (Deja, John Jeanette, Max and Tammy) meeting is scheduled at Deja's work place on 1-17.
