Don't have a pass, you can buy one or just bring a senior with you... most of us have one.

We are working on having a new step over built for accessing what's called Zone 6 near Rein Makers in Bloomington. We will have a work project day to do this installation in the very near future.

The April 8th chapter ride will be a ride, burger burn and movie featuring our very own Kayla Law. I saw the premiere and it's a real heart-warming tale. You don't want to miss it.

Hope you are ready for the really **BIG news**, hot off the email press. **Tim Walters** with Zion National Park was **successful in getting a grant** for connecting historic trails in the Chinle/ Coal Pits area, with our chapter as a partner. It's a big dollar amount for a big project for which we have a **significant involvement**. More details will be presented on April 5th, the educational session.



I don't know the back story associated with the next photo. Here is our chapter secretary, Jarice Butterfield and her daughter, Salina successfully riding their young horse Flicka.



Area 6


Needs a Stepover to the left of the gate

March 14, 2023 Meeting Minutes

Call to Order: Lin Hokana at 6:30PM

In Attendance: John West, Scott Ford, Carol Guilfoyle (guest from WA), Deja Scheitzer, Pat Wilson, Delray Jackson, Connie Jackson, Marie Langness, Mel Langness, Jim & Alice Allen (guests from South Dakota), Freddy Dunn, Larry Dunn, Paul Sloane, DeAnn Fieselman, Bobby Jo Wetsel, Tammy Lineback. Pledge of Allegiance and Introductions

Educational Presentation: Dawna Ferris-Rowley, Manager, Red Cliffs NCA

Dawna reviewed all the projects that have recently been completed, as well as future needs.

- -Trail maintenance remarking trails, addressing erosion, etc.
- -New Fencing being stalled starting late April
- -Working with the Forrest Service on new trails (shared use)
- -Mountain biker education on the trail; possibility of partnering on outreach with BCHU
- -Network with TASU group; school mountain bike groups; possibly create committee
- -There were 625,000 visitors to the local trails last year per traffic counters
- -There is a step over on Red Mountain that needs to be rebuilt
- -Dawna noted that if you have the Senior Pass you get in to the parks free (no fee then at Harrisburg trailhead hang pass on rear view mirror)

Minutes: Motion to accept/corrected as published in the newsletter made and passed

Treasurer's Report: Freddy Dunn reported. Motion made and passed to accept the report.

Review of Prior Business:

- Emergency Evacuation Plan Lin will attend and seek assistance at the Dammeron Valley Fire and Rescue open house on April 22.
- **501(c)3 application status** –this BCHU SW chapter qualifies for the EZ form (Lin and Freddy will meet and complete); The fee will range from \$275-600 and is a line item in the budget.

New Business:

• Preparing an annual budget – A discussion took place regarding the need for an annual budget with specified line items to be adopted by the organization so that expenditures can be made when needed without getting chapter approval prior to each expenditure. A proposed annual budget was presented and line items discussed. The total proposed annual expenses exceeded annual income. However, there are reserves to cover the deficit if needed. Work project expenses, the largest expenditures, could be covered in part or whole with grants.

A Motion to approve an annual budget was made and passed.

• Change meeting day to 1st Wednesday & new format – It was proposed that the monthly meeting be split into two parts: A business meeting that would take place at 5:30pm (all members can attend if desired) followed by a 1-hour educational and informational meeting starting at 6:30pm. Due to the availability of the meeting room, the day will be changed to the first Wednesday of every month. The proposed change would start in April 5, 2023.

Motion made to approve - passed

• Signage re bicycles for public lands – Lin will convene a committee

Committee Reports:

Liaison to local public lands agencies: Lin Hokana /Freddy Dunn, Co-chairs

- Future corrals at Pine Valley meeting with Charity Jessop/Larry Velarde; this project has been delayed to a later time, details forthcoming.
- Exit 13 meeting with Paul Walker, Washington City Assistant Leisure Services Director Lin sent a letter of support from the chapter supporting their grant application. The "Grapevine Crossing" trailhead is being refurbished this summer.
- New Mountain Trail Course (https://www.bolenderhorsepark.com/imtca-about/) on BLM land/Three Peaks Rec Area (near Cedar City) and request for letter of support from Christine Fletcher (4-H group) for their grant application (it will include an obstacle course, more trails, etc.); Lin sent a letter of support from the chapter supporting their grant application. This would be a 2-year project.
- Zone 6 Desert Reserve Step Over A the group went up to review a spot where a stepover could be constructed. This is near the Rain Makers Equestrian Center. With the approval of the annual budget this work can proceed. Lin will be in touch about a date and time. Volunteers are needed to install the stepover.
- An update on Private Stock riding in Bryce was presented.
- The Santa Clara Trail Head the gate accessing the trail now has a sign infringing into the opening, making it a hazard to get equines through it. Lin will contact the BLM about the possibility of installing a stepover with a gate (cattle grazing area).
- Grant Updates Committee Formed: Jarice and Lin
- BCHA has grants, deadline tomorrow 3-15-23
- BCHUtah has grant money available
- National Wilderness Stewardship Alliance, deadline to apply is April 15, 2023
- Utah Outdoor Recreation Grant, deadline to apply is March 17, 2023
- Zion NP and grant applied for; waiting to hear



Leaving the cul-de-sac clear for others to turn around. We will meet in the cul-de-sac and ride from there. When we finish, the ride, horses will be tied in an arena. Horses probably should not be left at their trailers because of the narrow road.

Natalie says the trail would be intermediate, she takes beginner riders on it all the time but they are riding horses used to the trail. The trail has a few steeper, climbs and rocky sections. Round-trip is about 6 miles.
