Another group of friends and members followed along a little later: Brooke Weaver (Guide), Amanda and Kailey Heinritz, and some friends from Reinmakers' Ranch.

Once again, the Schmalz' earned the award of traveling the farthest to be with the group (five hours) for "horse therapy". They must really like us!

It was a beautiful day and great ride through the gulch. Several members (11 all total) camped at the Paria River Ranch Campground the night before. Many were lucky enough to catch a ride that evening at Long Canyon and other areas.

The next morning the 11 members were joined by Debbie Barton and Jarice Butterfield for a total of 13 people and 14 horses. The group was saddled up and ready to ride near 9am. The fearless, energetic leader, Jeanette Blaisdell lead the group as the trail boss. The group was worried about encountering heat mid-day, so the ride was moved forward. There had been reports of earlier monsoon activity, and the parts of the trail that meandered through the canyon showed evidence of recent flooding. Some reported that there were far more rocks in the canyon than usual, which were most likely carried down by the recent rains or flash floods. There were spots where there was still water and mud in the canyon portion of the ride, and it made for a narrow adventure on horseback. All horses made it safely through the precarious spots with no injuries or difficulties.

The group met up in a beautiful shady, covered ravine surrounded by the massive red rock walls to eat a peaceful lunch. The horses all quietly stood and grazed on what little forage they could find while their riders stood or rested on the rocks while visiting and eating.

The weather was still mild for the return, and everyone made their way though the winding canyon with convening the ride out in the open space. It was a slow, peaceful ride for the most part. The ride was about 4 hours total from start to finish. Buckskin Gulch is definitely a favorite future spot and was worth the 2 hours plus drive!

There currently is no water provided for horses but there's a plan for a hydrant to be installed. This is a nicely constructed trailhead for trailers as well as for hikers and bikers and our chapter was invited to provide input on its design, which we greatly appreciate.


