We had 13 riders, plus Paul Sloane and Lin Hokana who joined us for lunch. The food was great and everyone had a great time visiting.



















The **BCHUSW** chapter meeting was called to order September 14, 2021 at the St. George Community Center by President Paul Sloane. In attendance were: Paul Sloane, Lin Hokana, Tammy Engeness, Delray Jackson, Connie Jackson, and Jeanette Blasdell.

Minutes: A motion was made, seconded, and passed to accept the last month's minutes as published in the August newsletter.

Treasurer' Report: A treasurer's report was not given.

Old Business:

Pine Valley Corral Project- The project is now in the forest service's hands as the engineers specifications have made the project much more extensive and costly.

Butler Challenge- A committee met and we hope our "Play Day" in October will entice more youth to attend. Paul has begun reaching out to the Dixie Rodeo Club, Deja has started contacting FFA groups, Jeanette will put up flyers at nearby stables, and we hope with the obstacle course which can be more youth friendly, members will invite their children or grandchildren to check it out. Our hope is to use the \$100 to award several youth memberships to interested participants. Jeanette has also volunteered to make a free membership available for an interested not as "youthful" participant.

Pine Valley Bridge Sign- The signs from a few years ago have become quite faded. Currently Star Design is developing alternate signs for approval.

Trail Etiquette Cards- Lin researched the cost of having cards printed up for our members to distribute while on the trails. He got quotes from: Staples, Alpha Graphics, Fed X and then at this meeting some other suggestions were given. A motion was made and accepted to allocate up to \$70 for the future purchase of cards.

New Business:

Play Day at Reinmakers- Connie and Delray Jackson have been gracious enough to let us use their facility for October's BCH gathering. With their input, we discussed the obstacles they have at their stable, and at a previous meeting we generated a list of other possibilities. Lin has volunteered to meet with Connie and Delray and design the course and also be the judge for the October 9th event. (This course will not be in their much used arena, so we will be able to start assembling the course way before the 9th for their stable members to enjoy.)

BCH Merchandise- In the past members have expressed an interest in having the BCH logo embroidered onto their favorite jacket, vest, shirt, etc. Jeanette contacted Power Image, which has our logo. The front logo is \$13.50 and the back logo is \$25.00. Interested members can bring their items the day of the Play Date or deliver them to Jeanette beforehand. The company has been very busy so it may take a couple of months to get them back. The cutoff date to drop off items will be October 9th.

National Public Lands Day- On September 25th Deja and Jeanette will be beginning a tumbleweed eradication project in the horse trailer staging area. There will be a ride to follow for those that can tolerate the heat.
