Troy Higgs –Brand Inspector, Utah Dept. of Agriculture. Troy also serves as Utah's Livestock Investigator and has served for twenty year tenure with Utah. tjhiggs@utah.gov/www.ag.utah.gov

Few changes within the year: Lifetime Brand Inspections are now \$50, thereafter \$35/horse. \$10 duplicates are the hard yellow card. \$20 FEE. Everything has been computerized now. Costs of everything has gone up. The yellow brand card is no longer available. The paper brand inspection you get can be laminated. No changes to holders of existing yellow cards; they are "life time". \$200 fine if you don't have your brand inspection, with your valid signature. Life times are only good on EQUINE. No other stock of any kind.

Troy's colleague, Kent Thurgood, sits on the Utah State Brand Inspection Board.

Registering a brand: \$250 each, up to 6-8 positions. Must be renewed every five years.

Past identification: No more tattoos on Thoroughbred lips; only microchips.

Brand Inspections: (Cattle) and equine: When you acquire your horse, you must have your brand inspection. Both seller and buyers are responsible for their own horses' brand inspections. This is a legal responsibility. Registration papers, life time travel permit, out of state, permits. Yearly permits are fiscal only Jan-Dec. Sworn statements from those who haven't done this can be gotten to Troy and he will get

it branded. Brand is state by state; know your state(s). Coggins absolutely required between/among states. Brands also needed when visiting your National Parks. Also required is Certified Hay, Rabies, Coggins. All paperwork must be carried on you while in the saddle.

If DRIVER is even hauling with owner, Brand Inspection and signed written permission with driver is required. No notary required at this time. Keep your paperwork up to date.

Trusts could/should include disposition of horse ownership.

Troy encouraging a rendezvous of anyone/everyone interested for brand inspections. Group will get together with thoughts and to find a venue for this rendezvous.

Ports of Entry: You can pretty much "blow through" (Utah) but Troy suggests you go thru the Port of Entry for either green or red lights. COVID has pretty much eliminated the need to actually stop. Elk is, however, inspected, required. (Randy Marriott, self-sufficient and largest ranch-raised elk contractor with a big elk farm in Canada.)
